### INSTRUCTIONS:

1. Read the instructions carefully. Fill in the entire form or risk disqualification. Sign it and mail it in with your entry fee or bring it in to Double Barrel in person.
2. ENTRY FEE: \$25.00 for amateurs. Entry DEADLINE is on Friday, July 18th, 7:00 pm.
3. The contest is limited to the first 100 contestants. Enter early!
4. This amateur event is open to everyone. There will be prizes for the winners. AGE GROUPS: 8-under, 9-11, 12-14, 15-17, 18--up. Girls 14 & under, Women 15 & up. Your age as of July 14, 2007 will determine your age group.
5. JUDGING AND SCORING: The skimboarder who completes the most radical, controlled maneuvers, in the most critical section of the biggest and/or best waves, for the longest functional distance, will earn the highest scores. The competitors will be judged on their top 7 rides. Scores are totaled and riders ranked 1 to 4 by each judge, then 3 judges rankings are totaled (highest and lowest judges scores are thrown out), lowest total wins. example: (four 1sts = 4) (four 4ths = 16) (two 2nds+ two 3rds= 10)
6. CUTOFF penalty: Waves belong to the first rider to clearly maneuver into position closest to the curl, or signal his intentions, verbally or otherwise. CUTOFF PENALTY: the guilty rider could loose his highest scoring ride off his total score from each judge. Risk a cutoff and risk the heat.
7. HEATS: Heats will be arranged based on previous contest experience listed on entry form. The heats will be arranged and seeded in advance with the most experienced skimmers spread out as far apart as possible. There will usually be 4 competitors per heat, and the 2 highest scores will advance.
8. If you are not there when your heat is called, you will be disqualified. We will have a schedule posted for the sequence of divisions that day.
9. PARKING is available at the beach. Sand Key is metered parking(Quarters) and there is a change machine in the park. Arrive early to ensure that you get a space. Plan to stay the whole day.
10. No promotional banners or tents allowed except for Official Contest Sponsors.
11. Awards will be on the beach, Saturday afternoon, after the contest is over.
12. We will be using 4 judges. We will have a spotter in the water.
